2. The sealed tenders shall be submitted on or before **05.03.2020 up to 2.00 P.M.** at **A.P.S.S.D.C. Ltd., H.O.:D.No.4-150, Prasadampadu, Ramavarappadu Post, Vijayawada-521108** and Tenders will be opened at **2.30 P.M.** on the same day in the presence of the tenderers or their representatives who ever so present at the time of opening the tenders by the tender committee.
3. Tenders shall be submitted in the prescribed serially numbered form only, provided by the APSSDCL, otherwise the same shall be liable to be rejected.
4. The tenderer shall submit the tender duly sealed and super scribing the description of crop on the cover without fail.
5. The quantity indicated in the tender notice is only tentative and the A.P.S.S.D.C. Ltd. does not guarantee that the purchase orders will be placed with the successful tenderer for the full / entire quantity indicated in the tender notice. APSSDCL shall only place orders for quantity based on its actual requirement.

6. The APSSDCL will not be responsible for any postal delay and tenders received after scheduled date and time/due date or not meeting the requisite tender conditions, shall summarily be rejected. Conditional tender will not be entertained.
7. The tenderer should submit a valid Seed Licence issued by the Joint Director of Agriculture concerned / Central Seed Licence issued by Addl. D.A.(Seeds) failing which, the tender would be deemed rejected.
8. The Seed produce is to be processed and should be packed at the cost of Tenderer/ producer / supplier, as per the norms as laid in the terms and conditions of the agreement between Corporation and the tenderers
9. The tenderer has to bear the cost of certification material i.e. bags, labels and seed treatment chemical etc.,.
10. Quality of Seeds supplied should be as per the standards mentioned in condition No (1) of the terms and conditions and with good luster.
11. The rates quoted should be inclusive of all costs, taxes, duties, cleaning / processing, packing charges, transportation, octroi, insurance etc., if any on F.O.R. destination basis. **No additional cost over and above the rate quoted by the tenderer will be considered on any grounds. Purchase Tax, GST if any, levied on the supplies by the Commercial Tax Authorities shall be born by the tenderer without any ambiguity.** The TIN No. has to be mentioned clearly in the invoices.
12. The deliveries are to be made on F.O.R. destination as per the delivery schedules given by the A.P.S.S.D.C. Ltd.
13. The tender/ rate should be valid for a period of **TEN** months only and remain in force for supply of seed during the agreement period. Any tender with escalation / price adjustment clause will be treated as conditional and will therefore be treated as invalid. The rates should be given in the format enclosed.

14. **An Earnest Money Deposit** amount should be made along with the tender by way of Demand Draft drawn for **Rs.10.00 lakhs** (Rupees Ten Lakhs only) for Dhaincha, **Rs.5.00 Lakhs** (Rupees Five Lakhs only) for Sunhemp & **Rs.7.00 Lakhs** (Rupees Seven Lakhs only) for Pillipesara T/L seed on any **Nationalized Bank / Private Sector Banks (ICICI, HDFC, AXIS, or any scheduled banks)** in favor of **A.P.S.S.D.C. Ltd., Vijayawada payable at Vijayawada**. Tenders without E.M.D. will summarily be rejected. The E.M.D. of unsuccessful tenderers will be returned only after finalization of the tender.
15. The E.M.D. submitted by the successful tenderer will be adjusted against the Security Deposit and it will not carry any interest.
16. There is no exemption from E.M.D. to the any individual/firm including Co-operative Institutions / Other Government Agencies / Public Sector Undertakings etc.,
17. The tenderer should have the required processing capacity for execution of supply in schedule time.
18. The tenderer should have the valid GST registration. Any tender application submitted without a valid GST registration certificate shall summarily be rejected. For the purchases made from outside the State, the tenderer has to reduce the price to the extent of set off Tax being eligible for the supplies of A.P.
19. The tenderer shall commence the supply immediately and complete the quantity within a week from the date of issue of supply order, to the sale points or as directed by the APSSDCL from time to time.
20. The tenderer shall indemnify the A.P.S.S.D.C. Ltd. for any loss sustained by it due to the improper or non-performance of the contract awarded to the tenderer. If the tenderer does not maintain the agreed delivery schedule or supplies or contain substandard quality including luster for any reasons, it shall interalia, amount to non-performance of the contract. In such case, the A.P.S.S.D.C. Ltd. reserves the right to procure the seed from any other tenderers as an alternate arrangement to mitigate the demand from the farmers and in this event the default tenderer shall be liable to bear all the damages / loses and the Security Deposit shall be fortified besides levying penalty/damages as decided by A.P.S.S.D.C. Ltd., including additional cost, incurred by A.P.S.S.D.C. Ltd., on procuring/ processing /transporting seed etc/ compensation to the farmers .

21. The seed supplied by the tenderer shall confirm to the prescribed quality standards as mentioned in condition no (1) of the terms and conditions and in case it is found not confirming to the said quality standards either at the processing point or at the sale point, it will be summarily rejected at the cost of the tenderer. The freight charges and other incidental expenses if any incurred shall be recovered along with any or all other damages from the tenderer/supplier by the APSSDCL.
22. The tenderer shall be solely responsible for the quality of the seed supplied and any complaint with regard to quality aspects such as germination, purity (physical) moisture and genetic purity etc. In the event of any complaint on quality of seed at field level i.e., germination, crop failure etc., the supplier only liable for all consequences including legal and financial liabilities etc., and shall pay all the compensation/damages as decided by a Committee / a Team of Officials constituted for the purpose / Department of Agriculture or APSSDCL alone.
23. Old seed or last season seed or non- seed shall not be mixed /supplied in the name of freshly harvested seed. The seed supplied should be of standard as per seed quality IMSCS in its parameters.
24. **Payment:** Payment for 75% of the value of the seed supplied will be made within 15 days on submission of analysis report / Quality Test Reports of STL/ QC Lab, the seed supply report and stock receipt acknowledgement from the concerned District Manager (seeds), APSSDCL and the balance amount will be released on receipt of the subsidy amount from the Special Commissioner of Agriculture, A.P., Guntur.
25. The Tender Committee reserves the right to negotiate with any or all the tenderers as considered necessary and reserves the right to place order on any one or more or on all tenderers as deemed fit.
26. The tenderer shall not sub-contract any job including supply of seed.
27. The Tender Committee reserves the right to accept or reject any or all the tenders without assigning any reasons whatsoever.
28. In case of any dispute, regarding tender process, the Tender Committee shall be the competent authority to settle the dispute. The decision of the Tender Committee shall be final and binding on all the tenderers.

29. The successful tenderer shall enter an agreement with the A.P.S.S.D.C. Ltd. on non-judicial stamp paper of value Rs.100/-.
30. Once the agreement is entered successfully with the APSSDCL, the supplier shall understand that he shall supply the seed at the same rate/ agreed rate for the entire agreed quantity, as and when asked to supply the seed by the officials of APSSDCL telephonically or SMS or E-mail or Whatsapp or by a letter, the supplier shall supply the seed as per the instructions within 2 to 3 days from the date of such request without fail. In case of failure in supply or not honoring the instructions as per the agreement, the supplier not only will be put in blacklist but also all the amounts including E.M.D, the value/ cost of the seed already supplied, held by the APSSDCL will be confiscated/ freezed and in such case no request/demand/ claim will be entertained at any cost.
31. A self profile of the Company/Organiser/Tenderer should be enclosed on processing plant capacity and previous experience on the seed supplies in the enclosed proforma along with the supporting documents.
32. The terms and conditions shall form the part of the Agreement to be executed by the tenderer.
