- (1) The sealed tenders/quotations are invited for supply of Freshly harvested Groundnut K-6 T/L Seed and sealed tenders shall be submitted on or before **30.10.2019 up to 12.00 P.M. at A.P.S.S.D.C. Ltd., Vijayawada** and the same **will be opened at 12.30 P.M.** in the presence of the representatives of the tenderers who so ever present/ ever not present, **on the same day** by the tender committee.
- (2) Tenders shall be submitted in the prescribed form only, which are serially numbered and provided by this office otherwise they are liable to be rejected.
- (3) The tenderer shall submit the quotation duly sealed and super scribing the description of crop on the cover without fail.
- (4) The quantity indicated in the tender notice is only tentative and the A.P.S.S.D.C. Ltd. does not guarantee to purchase orders will be placed with the successful tenderer for the entire quantity indicated in the tender notice. APSSDCL will only place orders for the required quantity on **F.O.R & OUTRIGHT PURCHASE BASIS FOR DISTRIBUTION ON SUBSIDY DURING Rabi 2019-20** based on its actual requirement.
- (5) This Office will not be responsible for any postal delay and tenders received late or not meeting the tender conditions and such tenders deemed to be not received & will be rejected. Conditional offers will not be entertained.
- (6) The tenderer should submit valid Seed License issued by Joint Director of Agriculture concerned /Central Seed License issued by Addl. D.A. (Seeds) failing which the tender would be rejected.

- (7) The Seed produced is to be processed and should be packed at the cost of producer / supplier and processed and packed seed as per seed standards shall be supplied to the APSSDCL.
- (8) The Supplier has to bear the cost of bags, labels and seed treatment chemical for Truthfully labeled seed.
- (9) Quantity of Seeds supplied should be as per the Indian Minimum Seed Certification standards and with good luster.
- (10) The rates quoted should be inclusive of all costs, taxes, duties, cleaning / processing, packing charges, transportation, octroi, insurance etc., if any on F.O.R. destination, basis. **No higher rate will be considered on any grounds. Purchase Tax, GST if any, levied on the supplies by the Tax Authorities will be collected separately.** The TIN No. has to be mentioned clearly in the invoices.
- (11) The deliveries are to be made on F.O.R. destination as per the delivery schedules given by the A.P.S.S.D.C. Ltd.
- (12) The quotation should be valid for a period of 3 (Three) months for acceptance and remain in force for supply during the contract period. Any quotation with escalation / price adjustment clause will be treated as conditional and will therefore be treated as invalid. The rates should be given in the format enclosed.
- (13) **An Earnest Money Deposit** amount prescribed for the Crop should be submitted along with the tender by way of Demand Draft drawn for **Rs.7.00 lakhs** from **any Nationalized Bank / Private Sector Banks (ICICI, HDFC, AXIS, ING Vysya Bank) in favor of A.P.S.S.D.C. Ltd., Vijayawada payable at Vijayawada.** Tenders without E.M.D. will be rejected. The E.M.D. of unsuccessful tenderers will be returned only after finalization of the tender.
- (14) The E.M.D. submitted by the successful tenderer will be adjusted as a Security Deposit and it will not carry any interest.
- (15) There is no exemption for E.M.D. to the Cooperative Institutions / Other Government Agencies / Public Sector Undertakings.
- (16) The tenderer should have the required processing capacity for execution of supply order in schedule time.
- (17) The tenderer should undertake that the seed processing will be carried at only one premises. The processing at more than one point will not be allowed unless there is written permission from the A.P.S.S.D.C. Ltd.
- (18) The tenderer should have the valid GST registration. For the purchases made from outside the State, the supplier has to reduce the price to the extent of set off Tax being eligible for the supplies of A.P.

- (19) The tenderer shall commence the supply immediately and complete the supplies within a week from the date of issue of supply order to the destination point.
- (20) The tenderer shall indemnify the A.P.S.S.D.C. Ltd. for any loss sustained by it due to the improper or non-performance of the contract awarded to the supplier. If the tenderer does not maintain the agreed delivery schedule or supplies contain substandard quality for any reasons, it will, inter alia, amount to non-performance of the contract. In such case the A.P.S.S.D.C. Ltd. reserves the right to procure the seed from other tenderers and tenderer shall be liable to lose the Security Deposit besides payment of penalty/ collateral damages as decided by A.P.S.S.D.C. Ltd., including additional cost, incurred by A.P.S.S.D.C. Ltd., which shall be recovered from the tenderers as the case may be.
- (21) The seed supplied by the tenderer shall confirm to the prescribed quality parameters and in case it is found not confirming to the quality parameters either at the processing point or at the sale points, it will be rejected at the cost of the tenderer. The freight charges and other incidental expenses if any incurred will be recovered from the tenderer by the concerned.
- (22) In case of germination failure due to poor quality of seeds, the compensation as awarded by the Consumer Court / District Level / State Level M.O.U. Committee, shall be paid by the tenderer.
- (23) **Payment:** Payment for **75%** of the value of the seed supplied will be made within 15 days on submission of analysis report of the STL / Quality Test Reports of QC Lab, the seed supply report and the stock receipt acknowledgement. The balance amount will be released on receipt of the subsidy amount from the Director of Agriculture, A.P., Guntur and the Quality Test reports of Q.C. Lab of the Corporation.
- (24) If any dispute arises on the seed supplied including its quality, at any point, the tenderer shall be responsible to pay the legal expenses and compensation etc., as per the orders of the Consumer Court / M.O.U. Committee / Other Courts or other authorities.
- (25) The Tender Committee reserves the right to negotiate with any or all the tenderers or cancel the entire tender process or not negotiate with any or all tenderers as considered necessary and further reserves the right to place supply order on any one or more or on all tenderers or not place any supply order on any or all tenderers as deemed fit.
- (26) The tenderer shall not sub-contract any part/full job including supply of seed.
- (27) The Tender Committee reserves the right to accept or reject any or all the tenders without assigning any reasons whatsoever.

- (28) In case of any dispute, the Tender Committee mentioned above shall be the competent authority to settle the dispute. The decision taken by the Tender Committee will be final and binding on the tenderers.
- (29) The successful tenderer will enter into an agreement with the A.P.S.S.D.C. Ltd. on non-judicial stamp paper worth Rs.100/-.
- (30) A self profile should be enclosed on processing plant capacity and previous experience on the seed supplies and should be submitted in the enclosed proforma along with the supporting documents.
- (31) The terms and conditions shall form the part of the Agreement to be executed by the successful tenderer.
